2. The Written Test for the said post is scheduled on **25th Oct. 2018**. The reporting time at the venue is 8.30 am. The venue for the conduct of Skill and Written Test is: **Central University of South Bihar, SH-7, Gaya-Panchanpur Road, Village Karhara, Post Fatehpur, P.S.Tekari, Gaya.**

3. INSTRUCTION TO CANDIDATES

- 3.1 The candidate is required to bring valid Photo ID proof in original and all original certificates with respect to academic qualifications including marks sheets, certificates, testimonials along with necessary documents for the claim of experience along with one set of self-attested documents (xerox copy) in support of the submitted application form.
- 3.2 The details of the test modalities are given below:

Skill Test: Essential qualifying test	• Test in driving with valid LMV Driving license.
	• Operational skills of office equipment's.
	• Attending Staff and University guests etc.
	• The candidate has to score 50 % marks.
Written Test: To draw merit	• Written MCQ test for 100 marks. Each question carries 1 mark. Every wrong answer will attract 0.25 negative marking.
	• The candidate has to score minimum 40 % marks in this test.

- 3.3 Mere appearance in any test(s) does not entitle a candidate to be considered for the appointment unless he/she fulfils the eligibility conditions as well. Applicants must fully satisfy themselves about their eligibility as prescribed in the advertisement, before appearing in the test. If an applicant is inadvertently allowed to appear in the Test(s), who otherwise does not fulfil the minimum eligibility requirements, he/she cannot, at a later date, use this as a right to claim that he/she meets the eligibility requirements.

- 3.4 In case, the candidate is employed and the application has not been forwarded through proper channel, the candidate is required to bring 'No Objection Certificate' from the present employer without which the candidate may not be allowed to appear for the said Test(s).
- 3.5 The candidate has to bear his/her own travelling and other expenses.
- 3.6 The candidate is also requested to go through "General Instruction to Candidates" available at University website (www.cusb.ac.in).
- 3.7 The applicants may kindly note that it takes 12-15 minutes brisk walk to reach the test venue, from the University main gate.
