



I. Essential qualifications for the post of PROFESSOR in Arts, Humanities, Law, Social Sciences, Sciences and Physical Education.

For concerned/allied/relevant discipline Master's Degree should be in subjects/branches as given at Sl. No. VII (Page No. 06)

- A.**
- (i) An eminent scholar having a Ph.D degree in the concerned/allied/relevant discipline, and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in the peer-reviewed or UGC-listed journals and a total research score of 120 as per the criteria given in Appendix II, Table 2 of **UGC Regulations, 2018. (Annexure-I)**
 - (ii) A minimum of ten years of teaching experience in University/College as Assistant Professor/Associate Professor/Professor, and /or research experience at equivalent level at the University/National Level Institutions with evidence of having successfully guided doctoral candidate.

OR

- B.** An outstanding professional, having a Ph.D degree in the relevant/allied/applied disciplines, from any academic institutions (not included in A above)/industry, who has made significant contribution to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience.

II. Essential qualifications for the post of ASSOCIATE PROFESSOR in Arts, Commerce, Education, Law, Social Sciences, Sciences, Languages and Journalism & Mass Communication.

***For concerned/allied/relevant discipline Master's Degree should be in subjects/branches as given at Sl. No. VII (Page No. 06)**

- (i) A good academic record, with a Ph.D. Degree in the concerned/allied/relevant disciplines.
- (ii) A Master's* Degree with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).
- (iii) A minimum of eight years of experience of teaching and /or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy five (75) as per the criteria given in Appendix II, Table 2 of **UGC Regulation, 2018. (Annexure-I).**

III. Essential qualifications for the post of ASSOCIATE PROFESSOR in Education.

- (i) A Postgraduate degree with a minimum of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) in the discipline relevant to the area of specialization,
- (ii) A Postgraduate degree in Education (M.Ed./M.A. Education) with minimum 55% marks (or an equivalent grade in a point scale wherever grading system is followed),
- (iii) A good academic record with Ph.D. Degree in Education or in the discipline relevant to the area of specialization,
- (iv) A minimum of eight years of experience of teaching and / or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy five (75) as per the criteria given in Appendix II, Table 2 of the UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, 2018.

***For concerned/allied/relevant discipline Master's Degree should be in subjects/branches as given at Sl. No. VII (Page No. 06)**

A.

- (i) A Master's* degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign University.
- (ii) Beside fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. Programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a referred journal;
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dean(Academic Affairs) of the University concerned.

Note 1: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

Note 2: The National Eligibility Test (NET) or an accredited test (State Level Eligibility Test SLET/SET) shall remain the minimum eligibility for appointment of Assistant Professor and equivalent positions wherever provided in UGC Regulations. Further, SLET/SET shall be valid as the minimum eligibility for direct recruitment to Universities/Colleges/Institutions in the respective state only.

OR

- B. The Ph.D. degree has been obtained from a foreign University/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:
- (i) Quacquarelli Symonds (QS)
 - (ii) the Times Higher Education (THE) or
 - (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

Note: The Academic score as specified in Appendix II (Table 3A) of UGC Regulations, 2018 for Universities shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview. (**Annexure-II**).



V. Essential qualifications for the post of ASSISTANT PROFESSOR in Pharmacy.

B.Pharm and M.Pharm. in relevant specialization with First Class or equivalent in any one of the two degrees.

Note: Candidates who have done Ph.D after the Bachelor's Degree from institution of National importance with GPAT shall be eligible for the post of Assistant Professor.

VI. (A) Essential qualifications for the post of ASSISTANT PROFESSOR in Education (Pedagogy of Mathematics, Pedagogy of Sciences, Pedagogy of Social Science, Pedagogy of Language, Perspective of Education/Foundation Course and Open)

Common Essential Qualification:

- (i) M.Ed. degree with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) from an Indian University, or an equivalent degree from an accredited foreign university.
- (ii) Beside fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET)/JRF in Education conducted by the UGC or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in Education in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. Programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a referred journal;
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note 1: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

Note 2: The National Eligibility Test (NET) or an accredited test (State Level Eligibility Test SLET/SET) shall remain the minimum eligibility for appointment of Assistant Professor and equivalent positions wherever provided in UGC Regulations. Further, SLET/SET shall be valid as the minimum eligibility for direct recruitment to Universities/Colleges/Institutions in the respective state only.

OR

The Ph.D. degree has been obtained from a foreign University/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).



Specific Essential and Desirable qualification (according to area of Specialization) in addition to the above mentioned common essential qualification:

Pedagogy of Mathematics – 01 Post – Essential: M.Sc. in Mathematics with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) from an Indian University, or an equivalent degree from an accredited foreign university.

Desirable: National Eligibility Test (NET)/JRF in Mathematics conducted by the UGC or CSIR or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in Mathematics in accordance with the UGC regulations as mentioned above.

Pedagogy of Language (English) – 02 Posts – Essential: M.A. in English with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) from an Indian University, or an equivalent degree from an accredited foreign university.

Desirable: National Eligibility Test (NET)/JRF in English conducted by the UGC or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in English in accordance with the UGC regulations as mentioned above.

Pedagogy of Science (Physics) – 01 Post – Essential: M.Sc. in Physics with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) from an Indian University, or an equivalent degree from an accredited foreign university.

Desirable: National Eligibility Test (NET)/JRF in Physics conducted by the UGC or CSIR or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in Physics in accordance with the UGC regulations as mentioned above.

Pedagogy of Science (Botany/Plant Science) – 01 Post – Essential: M.Sc. in Botany/Plant Science with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) from an Indian University, or an equivalent degree from an accredited foreign university.

Desirable: National Eligibility Test (NET)/JRF in Botany/Plant Science conducted by the UGC or CSIR or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in Botany/Plant Science in accordance with the UGC regulations as mentioned above.

Pedagogy of Science (Zoology/Animal Science) – 01 Post – Essential: M.Sc. in Zoology/Animal Science with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) from an Indian University, or an equivalent degree from an accredited foreign university.

Desirable: National Eligibility Test (NET)/JRF in Zoology/Animal Science conducted by the UGC or CSIR or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in Zoology/Animal Science in accordance with the UGC regulations as mentioned above.

Pedagogy of Social Science (Geography) – 01 Post – Essential: Postgraduate degree in Geography with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) from an Indian University, or an equivalent degree from an accredited foreign university.

Desirable: National Eligibility Test (NET)/JRF in Geography conducted by the UGC or CSIR or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in Geography in accordance with the UGC regulations as mentioned above.

Pedagogy of Social Science (History) – 01 Post – Essential: M.A. in History with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) from an Indian University, or an equivalent degree from an accredited foreign university.

Desirable: National Eligibility Test (NET)/JRF in History conducted by the UGC or CSIR or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in History in accordance with the UGC regulations as mentioned above.



Open – 01 Post – Essential: A Postgraduate degree in Mathematics/Sciences/Social Sciences/Languages with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) from an Indian University, or an equivalent degree from an accredited foreign university.

Desirable: National Eligibility Test (NET)/JRF in Mathematics/Sciences/Social Sciences/Languages conducted by the UGC or CSIR or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in Mathematics/Sciences/Social Sciences/Languages in accordance with the UGC regulations as mentioned above.

##Perspective of Education/Foundation Course – 01 Post – Essential: Postgraduate degree in Social Science/Philosophy with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) from an Indian University, or an equivalent degree from an accredited foreign university.

Desirable: National Eligibility Test (NET)/JRF in the relevant Social Science subject/Philosophy conducted by the UGC or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in Social Sciences in accordance with the UGC regulations as mentioned above.

For this Post (i) of Sl. No. VI (A) (Common Essential qualification) should be read as follows:

M.Ed. degree with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) from an Indian University, or an equivalent degree from an accredited foreign university

Or

Desirable: (i) B.Ed. from any recognized University. (ii) National Eligibility Test (NET)/JRF in Physical Education conducted by the UGC or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in Physical Education in accordance with the UGC regulations as mentioned above.

Visual Arts – 01 Post – Essential: A Postgraduate degree in Fine Arts (MFA) with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) from an Indian University, or an equivalent degree from an accredited foreign university.

Desirable: (i) B.Ed. from any recognized University. (ii) National Eligibility Test (NET)/JRF in the relevant subject conducted by the UGC or CSIR or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in Fine Arts in accordance with the UGC regulations as mentioned above.

Performing Arts – 01 Post) – Essential: A Postgraduate degree in Music/Dance/Theatre Arts with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) from an Indian University, or an equivalent degree from an accredited foreign university.

Desirable: (i) B.Ed. from any recognized University. (ii) National Eligibility Test (NET)/JRF in the relevant subject conducted by the UGC or CSIR or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in Music/Dance/Theatre Arts in accordance with the UGC regulations as mentioned above.
