**NOTICE FOR SEMESTER AND COURSE REGISTRATION**  
**FOR INTERMEDIATE BATCHES**  
**(Undgraduate and Postgraduate Programmes)**

All students of Undergraduate and Postgraduate programmes of Intermediate Batches are hereby directed to register themselves in **3<sup>rd</sup> / 5<sup>th</sup> / 7<sup>th</sup> / 9<sup>th</sup> Semester (July-December, 2025)** from **15.07.2025** to **25.07.2025** with deposition of prescribed semester fee at **Annexure-A** and further complete **course registration** through SAMARTH portal (<http://cusb.samarth.edu.in>).

A student who fails to register himself/herself within stipulated date will be charged **Rs.500/-** late fine from **26.07.2025** to **28.07.2025** and thereafter **Rs.1000/-** will be charged from **29.07.2025** to **31.07.2025**.


**No Semester and course Registration will be permitted after last date of semester registration in any case. While carrying out Semester registration, the students are directed to select their courses of their respective semester of the programme of studies for completion of course registration.**

Registration made in different courses within the stipulated period of time by a student shall not ordinarily be permitted to be changed. However, in exceptional cases, a student may be allowed by the Head of the concerned Department to add / replace a course (elective) with another course of the same type (elective) or withdraw from a course for valid reason not later than one week from the last date of course registration in a particular semester as per para-14.3 of "Ordinance Governing the Award of Master's Degree Programme in Arts/Commerce/Education/Science- 2022" and other admissible Ordinance and Regulation of the respective programme of Studies

**The concerned students must create their Academic Bank of Credit (ABC) ID before going to registration process. The ABC ID is mandatory to complete the semester registration process.**

All the concerned Heads of Departments are requested to expedite the registration process in pursuance of CUSB Notice No.CUSB/Acad/ AE7417 dated 27.12.2023 (copy enclosed.)
