## NOTIFICATION

The Academic Council of Central University of South Bihar in its 16<sup>th</sup> meeting held on 14<sup>th</sup> March, 2018 vide Resolution No. 04/AC-16/18 resolved to ratify the revised **Ordinance Governing the Award of Degree of Doctor of Philosophy – 2017** with following amendment in Clause X.2 relating to Quota of Ph.D. Supervisor, which shall be in consonance with the provision laid down in Clause 6.5 of UGC Ph.D. Regulation – 2016 and would be read as under :

Existing	Amended
a. The Maximum number of candidates who can be supervised by a faculty member at any point of time shall be follows: Professor : 6 Associate Professor : 4 Assistant Professor : 2	A Research Supervisor/Co-supervisor who is a Professor, at any given point of time, cannot guide more than three (3) M.Phil. and Eight (8) Ph.D. scholars. An Associate Professor as Research Supervisor can guide up to a maximum of two (2) M.Phil and Six (6) Ph.D. scholars and an Assistant Professor as Research Supervisor can guide up to a maximum of one (1) M.Phil and four (4) Ph.D. scholars

2. It was resolved to approve to add Hindi and Computer Science subjects with a provision to add more subjects in further in Annexure-A of the Ordinance related to the Details of Qualifying Examinations.

3. The Academic Council also considered the amendments recommended by the Ph.D. Ordinance Committee and resolved to approve the following amendments by adding sub-clauses in different Sections of the Ordinance, *inter-alia*, the examination of Ph.D. course-work and provisions for part-time Ph.D. for CUSB employees :

### **Addition in Clause No. V.1 (b) (XI):**

In this point 'by' is to be included 'accepted' and the concerned DRDC/CRDC in the following manner : ".....accepted by the concerned DRDC/CRDC".

### **Addition of Clause No. V.1 (b) (XII):**

"A teaching or a non-teaching employee of Central University of South Bihar, Gaya holding substantive position and recommended by the Head & Dean of the School in case of teachers and by the Registrar in case of non-teaching employee and accepted by the concerned DRDC/CRDC."

### **Addition in Clause No. VI.1 (b):**

In this point (xii) shall be included between '(xi)' and 'shall be referred' in the following manner.

".....(xi), (xi) and (xii) shall be referred...."

### **Addition in Clause No. XI.4 (i):**

The evaluation of the Course Code 901 & 902 shall be done by the concerned faculty-member and the evaluation report is to be sent to the Controller of Examinations office.

**Addition in Clause No. XI.4 (ii):**

For all the three courses there shall be only end semester examination of 100 marks. The Grades of these course shall be the same as that of respective PG courses and shall not be placed before the Board of Examiners.

**Addition in Clause No. XI.4 (iii):**

Regarding Course Code 903, it was decided that the 100 marks allotted for this will be split in two parts, 75% for research proposal writing and rest 25% for the presentation. This evaluation shall be done jointly by the RAC and the CRDC/DRDC and submitted to the Controller of Examinations.

**Addition of Clause No. XI.7 :**

A teaching or a non-teaching employee of Central University of South Bihar, Gaya holding substantive position shall complete his / her course work alongside performing his/her duties.

**Addition of Clause No. XIII.1 (a) :**

In case of medical emergency the leave may be extended by the Chairperson, URDC on the recommendations of DRDC/CRDC.

4. Subsequently, the Executive Council in its 35<sup>th</sup> meeting held on 26.03.2018 vide Resolution No. 06/EC-35/18 resolved to consider the above decisions of Academic Council and approved the same.

5. The amended **Ordinance Governing the Award of Degree of Doctor of Philosophy – 2017** after incorporating the amendments as approved by Academic Council followed by Executive Council is hereby notified.
